The company is said to have approvals for different combinations of the drug, i.e. Salicylic acid 12.5% w/w 20gm, Urea 12% w/w, cal. lact. 0.5%w/w, lactic acid 6%w/w, pot. chl. 0.5% w/w, mag. chl. 0.3% w/w, glycine 3% w/w, sod. acid phos. 0.5% w/w, amm. chl. 0.5% w/w, sod. chl. 0.5% w/w 50gm, Salicylic acid 2% w/w 75gm, Hydrocortisone acetate 0.5% w/w, salicylic acid 6% w/w, benzoic acid 12% w/w 15gm, Urea 10% w/w, lactic acid 10% w/w, propylene glycol 10% w/w, liquid paraffin 10% w/w 75gm, Salicylic acid 3% w/w, benzoic acid 6% w/w, menthol 0.08% w/w, starch 31% w/w, purified talc 100gm, Salicylic acid 6% w/w 30gm, Salicylic acid 12% w/w 30gm, Squalene, aloe vera, and vitamin E 50gm, Salicylic acid 3% w/w, benzoic acid 6% w/w 50gm.

The generic manufacturing strategies of New Drug Keratolytics And Cleansers and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
