The company is said to have approvals for different combinations of the drug, i.e. Lignocaine hcl 2% 30ml, Lignocaine hcl 2%, adrenaline 2% 30ml, Lignocaine hcl 42.66mg, methylparaben 0.10% w/v, propylparaben 0.05% w/v 10ml, Lignocaine hcl 2% w/w, methylparaben 0.10% w/v, propylparaben 0.05% w/v 30g, Lignocaine hcl 15%w/v 100gm, Lignocaine hcl 24.64mg, adrenaline 0.0125mg 30ml, Lignocaine hcl 20mg, methylparaben 1mg 30ml, Lignocaine hcl 21.3mg 2ml, Lignocaine hcl 10.7mg /ml 30ml, Lignocaine hcl 21.3mg/ml 30ml, Lignocaine hcl 21.3mg, adrenaline 0.005mg/ml 30ml, Lignocaine hcl 4% 30ml, Lignocaine hcl 5% w/w 10g, Lignocaine hcl 100mg /ml 500md.

The generic manufacturing strategies of New Drug Lignocaine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
